## Drilling underway on Shinganda Licence, Central western Zambia

The Company is pleased to confirm that Phase 3 RC drilling on the Shinganda Licence has commenced. Exploration including drilling to date has established the potential for a large IOCG-type target and the current programme is focusing on an approximate 10km strike length of Cu - Au mineral-bearing fault/shear targets along the Shinganda Main Fault and Splay structures broadly defined by the Company to date. These structures exposed at surface are proven to host copper - gold mineralisation within shears associated with the Shinganda Splay Fault.
